5. Pre-purchase stacks will be live on the table from the start of the tournament.
6. Levels will last 20 minutes each.
7. This tournament is scheduled for one day. The tournament director in their sole and absolute discretion may adjust the break, the start and stop time and level lengths.
8. A redraw at the final table 9 or Tournament director discretion.
9. Tournament uses big blind Ante. The blind is before the ante.

Players will have no claim or recourse in these matters. Management reserves the right to alter, change, or cancel this tournament.
