

Spring Champion's Series Sweepstakes Official Rules

OFFICIAL SWEEPSTAKES RULES

- **NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT IMPROVE YOUR ODDS OF WINNING.**
- **VOID WHERE PROHIBITED. ALL FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS APPLY.**
- **BY ENTERING THIS SWEEPSTAKES, THE ENTRANT AGREES TO THESE OFFICIAL SWEEPSTAKES RULES AS A BINDING CONTRACT.**

1. **Sponsor and Administrator**: Spring Champion's Series Sweepstakes Official Rules ("Sweepstakes") is sponsored and administered by Daytona Beach Racing and Card Club and Orange City Racing and Card Club (collectively the "Sponsor").

2. **General**: By participating in this Sweepstakes, the participant acknowledges and agrees to all these Official Rules. Void where prohibited. Sweepstakes begins on February 25, 2026, and runs until March 25, 2026 (collectively the "Sweepstakes Period"). The odds of winning a prize depend on the total number of eligible entries received during the Sweepstakes Period (each an "Entry"). Sponsor cannot accurately predict the number of entrants who will participate in the Sweepstakes (each an "Entrant"). All times in this Sweepstakes refer to Eastern Time. By participating, Entrants agree to be bound by these Official Rules and by all decisions of the Sponsor, whose decisions are at its sole discretion and are binding and final. Failure to comply with these rules will result in disqualification from this Sweepstakes.

3. **Eligibility**: The Sweepstakes is open only to legal U.S. residents and are 21 years of age or older as of February 25, 2026. Employees, officers, directors, managers and members, along with their respective immediate family members, of Sponsor and Delaware North Companies, Incorporated ("DNC") its affiliates, and any other entities involved in any manner with the marketing, sponsoring, fulfilling or administration of the Sweepstakes in addition to any licensee, registrant, contractor, subcontractor, consultant, officer, or employee of a contractor, subcontractor, licensee, registrant or consultant (collectively, the "Sweepstakes Entities"), are not eligible to participate or win. Normal Internet access, phone charges and usage charges imposed by your online/ phone service provider will apply. Entrants must include their name, age, phone number, email address and state of residence.

2) Entrants may also enter the Sweepstakes by visiting <https://www.orangecitypoker.com/event/spring-champions-series/> during the Sweepstakes Period and filling out a Sweepstakes Entry Form. Normal Internet access, phone charges and usage charges imposed by your online/ phone service provider will apply. Entrants must include their name, age, phone number, email address and state of residence.

Sponsor reserves the right to reject any Entry that it deems, in its sole discretion; to violate any of these content related requirements. By submitting an Entry (or accepting any prize), each Entrant understands and agrees that their Entry, including individual name may be posted online and further exploited by Sponsor for promotional purposes, without further compensation or review, and will not be returned. Each Entrant represents that the Entry is true and correct, and that he or she is authorized to submit such Entry. Sponsor reserves the right to crop or reformat any Entry in whole or in part, to be viewable online.

You may be asked to consent to receive promotional emails or offers. This is optional and does not affect your chances of winning a prize in this Sweepstakes. You are NOT required to give consent to receive such emails or offers in order to participate in the Sweepstakes or win any prize. You may opt out of this service at any time by clicking 'unsubscribe' within the email.

Limit of one Entry per person during the Entry Period. Multiple Entries as determined by Sponsor in its sole discretion, will result in disqualification of all Entries by such person. Entries that do not conform to or that violate these Official Rules or are submitted in any manner other than stated in these Official Rules will be disqualified. By entering this Sweepstakes, Entrants agree to these Official Rules and the decisions of the Sponsor, which are binding and final in all matters relating to this Sweepstakes.

Sponsor is not responsible for, nor assumes any liability for (i) any incorrect or inaccurate Entry information, or for any faulty, failed, garbled or jumbled electronic data transmissions; (ii) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes; (iii) any miscommunications related to this Sweepstakes; or (iv) any incorrect or inaccurate capture of information, or the failure to capture any information.

5. **Determination of Winner:** At the conclusion of the Sweepstakes Period, one (1) winner will be randomly selected. Winner will be selected at random from all eligible Entries. The winner will be notified via email on or about March 26, 2026. The Sponsor's decisions are final, binding and conclusive on all matters related to the Sweepstakes. If a winner is not responsive within twenty-four (24) hours of initial notification or in the event of non-compliance with any of these requirements, the prize will be forfeited, and an alternative winner will be chosen.

6. **Prizes:** One (1) prize will be awarded at the conclusion of the Sweepstakes Period. One winner will randomly be selected to receive an entry into the Leaderboard Championship, on Saturday March 28, 2026, at Orange City Poker. Estimated retail value is \$300.00. Prize will be uploaded directly onto winner's Lucky North Rewards card. Winner must be a Lucky North member to accept the prize. It is free to sign up for Lucky North rewards and winner may cancel membership at any time after March 28, 2026. In the event the prize is unavailable for any reason, Sponsor reserves the right to substitute or award an alternative prize of approximate value with no further obligation to the winner. Transfer of any prize is prohibited unless approved by Sponsor. All taxes and all other expenses, costs or fees, including parking and transportation, associated with the acceptance and/or use of a prize are the sole responsibility of the winner. The winner must present valid government-issued identification and provide taxpayer identification information. Sponsor may require additional verification of identity. Sponsor reserves the right to substitute a similar prize of equal or greater value at its sole discretion.

7. **Disclaimer and indemnity:** By submitting an Entry, each Entrant waives, discharges and fully releases the Sweepstakes Entities, along with such entities' respective officers, directors,

no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alternation of, Entries, (ii) are not responsible for any problems or technical malfunction of any telephone network or lines, computer on-line systems, servers, or provider, computer equipment, software, failure of any email to be received by the Sponsor on account of technical problems, human error or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage to the participant's or any other person's computer related to or resulting from participation or downloading any materials in this Sweepstakes. If there is a dispute as to the identity of an online Entrant, the prize will be awarded to the authorized account holder of the email address, as determined by Sponsor in its sole discretion.
